- 1. Reorganization Kristen Kollu

 - Also discussed the split of Department of Public Health and Department of Environmental Services effective July 1, 2024
 - She also noted about the relocation of the Department and provided an outline of what the Bureau of Nursing Home and Medical Services does
 - Kristen showed organization for the bureau and positions
- 2. Dialysis at Home Program Updates Kristen Kollu
 - As of now, there is only one nursing home that has submitted documents and has been approved
 - There have been two other nursing homes that have submitted interest
- 3. Top Citations/Deficiencies Kristen Kollu, Natasha Sharpe, Bridgett Ragin
 - o Licensing:
 - 1504.A Quarterly Fire Drills (13)

- Make sure to keep records and make sure to be reviewed
- 509.A Staff Health Assessment (8)
 - This is for direct care staff that should have completed a health assessment within 12 months prior to patient contact. Kristen suggested that each facility should make a checklist for new hires and should audit it
- 703.A Patient Care Plan (7)
 - Should be conducted within 30 calendar days or first 13 treatments
 - Inspectors will review this when conducting inspections
- 1703.C Staff TB (5)
 - Health Assessment, TB screening process
 - Make sure that staff has TB Baseline testing within 3 months prior to patient contact.
 - If there has been previous testing in the last 12 months, that can be used as first step but will have to get second step or BAMT before patient contact
- 1602 Equipment Maintenance (3)
 - General maintenance
 - Plumbing, fire protection, dialysis equipment, scales, etc...
 - Make sure there is a policy
 - Look at manufacturer's directions of equipment to see when routine maintenance is required
 - If anything should break between routine maintenance, everything should be documented
 - Facility should keep records of any maintenance

Federal:

- V0111- Infection Control-Sanitary Environment (22)
 - The facility must provide and monitor a sanitary environment to minimize the transmission of infectious agents within and between the unit and any adjacent
- V0401- Physical Environment- Safe, Functional, Comfortable Environment (22)
- V06081- Staff Licensed as Required/Qualified/Demonstrate Competencies (16)
 - The facility staff should meet the applicable scope of the practice board and licensure reequipments in effect State
- V0250-Dialysate Proportioning-Monitor PH/Conductivity (14)
 - The facility operator to allow manufacturer instruction regarding dialysate conductivity and to measure approximate pH with independent method
- V0113-Infection Control-Wear Gloves/Hand Hygiene (12)
