1. Jon Fehr - Advanced EMT Certificate

Inspection(s), Violation(s), and Enforcement: Department staff received allegations involving Fehr, at the time an EMT-Basic, and potential statutory and regulatory violations. Department staff conducted an investigation and determined Fehr committed a statutory and regulatory violation by signing a false ePCR listing another provider as the one who performed an IV procedure when in fact, he himself alone started an IV on a patient as an EMT Basic; initiated an IV on a patient, a skill only approved in South Carolina for AEMT and Paramedics, while certified as an EMT-Basic; and knowingly violated the protocols established by his Agency Medical Control physician by establishing an IV on a patient which was outside of his scope of practice as an EMT-Basic. On November 25, 2025, the Department and Fehr executed a Consent Order whereby Fehr agreed to make payment of a \$1,000 monetary penalty to the Department.

Prior Orders: None in the past five (5) years.

2. Hunter McDaniel - Paramedic Certificate

Inspection(s), **Violation(s)**, **and Enforcement:** Department staff received allegations involving Hunter and potential violations of statute and/or regulation. On November 14, 2025, and as a result of the seriousness of the allegations, the Department issued an Emergency Suspension Order suspending Hunter's certification on an emergency basis pending further investigation of the allegations.

Prior Orders: None in the past five (5) years.

3. Andrew McCarter – Paramedic Certificate

Inspection(s), Violation(s), and Enforcement: Department staff received allegations involving McCarver and potential regulatory violations. Department staff has initiated an investigation into the allegations that McCarver failed to provide adequate care to patients, violated treatment protocols, falsified documentation, misused physical restraint of an AMS patient, acted outside of his scope of practice, and created a substantial risk of harm to patients. Due to the nature of the allegation involves acts and/or omissions directly related to patient care, on November 20,2025, the Department issued an Emergency Suspension Order suspending McCarter's certification on an emergency basis pending further investigation of the allegations.
