Housing Opportunities for People Living with AIDS (HOPWA) Definitions

Facility-Based Housing Assistance provides a safe, stable place to live while receiving necessary support services.

Permanent Housing Placement (PHP) provides assistance with establishing permanent residence when continued occupancy is expected. PHP typically covers the first month's rent and security deposit (not to exceed two months) and/or one-time utility connection fees and processing costs.

Short Term Housing Services provides temporary shelter to eligible individuals to prevent homelessness and allow an opportunity to develop an individualized housing and service plan to guide the client's linkage to permanent housing.

Short-term Rent, Mortgage, and Utility Payment (STRMU) provides rent, mortgage, and/or utility payments intended to prevent homelessness of the tenant or mortgagor of a dwelling.

Supportive Services provides services including, but not limited to, case management, mental health, drug and alcohol abuse treatment and counseling, daycare, personal assistance, nutritional services, intensive care when required, and assistance in gaining access to local, state, and federal government benefits and services.

Tenant Based Rental Assistance (TBRA) provides long-term, stable housing to clients. For SC DPH-funded HOPWA providers, TBRA is provided by Fort Mill Housing Services.
